"There is no manual interference at all," said Sabet. The APIs and open architecture of APX mean there was no problem to link the front system with APX to maintain that automation."

During the day, custom reports in APX support the reconciliations of holdings and cash. At end of the day, the system conducts a full valuation and review of the client portfolios by issuing reports such as appraisals, P&L and change in net assets.

"Depending on the clients' requests, we also produce monthly or quarterly reports that detail the returns and what is happening in their portfolio," said Sabet. This responsive transparency is crucial in maintaining strong relationships with sophisticated institutional clients, which expect high quality, timely reporting.
