To continue, please read and acknowledge the following:

AGREEMENT AND RELEASE FOR ACTIVE EVENT (NON- EMPLOYEE)

WHEREAS, the undersigned (herein, "Participant"), who is not an employee of SS&C Technologies, Inc. or any of its affiliates or subsidiaries (individually or collectively herein, "Sponsor"), has been offered the opportunity to attend SS&C Advent Engage Conference (the "Event") to be online on September 14–15, 2021, subject to the condition that Participant enter into this Agreement.

Now, therefore, in consideration for Participant's online attendance at the Event and other good and valuable consideration, the receipt and sufficiency of which are acknowledged by Participant, Participant agrees as follows:

CONFIDENTIALITY

In connection with the Event, certain Confidential Information regarding Sponsor may be disclosed to the undersigned. Participant agrees that he/she will keep confidential and not disclose the Confidential Information presented during the Event. Participant will not use or disclose Sponsor's Confidential Information other than in connection with his/her business relationship with Sponsor and in compliance with applicable federal, state and local laws. "Confidential Information" shall mean for the purposes of this Agreement all information (printed, electronic, oral or otherwise) that is supplied by Sponsor during the Event. Participant acknowledges that he or she shall acquire no right to use without Sponsor's express written approval any tradenames, logos, trademarks or copyrighted materials of Sponsor.

WAIVER AND RELEASE:

Participant, on his/her behalf and on behalf of his/her heirs, executors, administrators, representatives and assigns, assumes full responsibility for all risks of any and all Losses of any nature, whether to property or person, related to Participant's online participation in the Event, and resulting from, arising out of, or in connection with the Event, including, but not limited to, access to the Event and participation in any group or individual online activities during the Event, whether or not such activities are organized by Sponsor or any third party, or losses caused to the Sponsor or its Participants arising from any viruses, worms, "Trojan horses", malicious software or malware transmitted by a third party parties ("Malicious Code").

Losses under this Agreement include, but are not limited to, the following: property damage, illness, personal injury and death, cost or expense (collectively "Losses"). Potential causes of Losses under this Agreement include, but are not limited to: cybercrime, fire, accident, acts of God, public enemy, riot, terrorism, , telecommunications, the Internet, Internet service provider or hosting facility failures or delays involving hardware, software, power systems or other failures beyond Sponsor's the Sponsor is not liable or responsible for any technical issues which may arise as a result of any incompatibility of Sponsor's or its event hosting provider's platform technology ("Event Platform") with Participant's systems, or for any unavailability, delay,

disruption or disturbance in the operation of the Event Platform, or problems caused by Sponsor's, the Event Platform's or Participants' internet service provider(s) or for any telecommunications failures which are beyond Sponsor's or the Event Platform's control that may hinder Participant's access to the Event, reasonable control, violation of applicable law, or any other casualty or calamity. Participant consents to sharing by Sponsor of his or her relevant personal data with relevant third parties involved in the Event, including without limitation, service providers, its Event Platform and external delivery partners for the purpose of carrying out its obligations under this Agreement

In consideration of his/her participation in the Event, Participant on his/her behalf and on behalf of his/her heirs, executors, administrators, and representatives hereby EXPRESSLY WAIVES, HOLDS HARMLESS, RELEASES AND FOREVER DISCHARGES Sponsor, Engage and each of their respective current, former, and future affiliates, officers, directors, employees, agents, successors and assigns respectively, (together, "Released Parties") from any and all claims, demands, liabilities, Losses, costs and expenses (including attorneys' fees), rights or causes of actions, present or future, known or unknown, anticipated or unanticipated, of damage, loss or injury of any kind or description whatsoever (collectively the "Claims"), resulting from, arising out of, or in connection with the Event.

INDEMNIFICATION:

To the fullest extent permitted by law, Participant agrees to indemnify and hold harmless the Released Parties from any and all Claims against any one of them which arise out of or in connection with the Event and which arise result, directly or indirectly, from Participant's actions or inaction, intentional or otherwise.

If any provision of this Agreement is determined to be invalid, such invalidity will not affect the validity of the remaining portions of this Agreement. This Agreement shall be binding upon the undersigned and upon its respective successors and assigns.
